The committee organized a programme for the students in collaboration with Maharashtra National Law University, Nagpur.</p> <p>The Legal Aid Camp aimed at sensitizing students on General Awareness on National Legal Service Authority; update the students about their Fundamental Rights, and also about Right to Information Act 2005 and Consumer Protection Act 1986.</p> <p>Professor Dr. Anirban Chakraborty from Maharashtra National Law University Nagpur gave an informative lecture on ‘General Awareness on National Legal Service Authority’ (NALSA). He said that National Legal Service Authority’ (NALSA) of India aimed to Provide free and competent legal services to eligible candidates, and to organize Lok Adalats for speedy resolution of cases.</p> <p>Dr. Ragini Khubalkar (MNLU) delivered her lecture on Right to Information Act 2005 and Consumer Protection Act 1986. 	<p>the basic aim of Right to Information Act 2005 is to empower the citizens, promote transparency and accountability in the working of the government, contain corruption, and make our democracy work for the people in real sense. She further added, the principle object of the consumer protection act is to provide better protection of the interest of consumers and for the purpose, to make provision for the establishment of Consumer Councils and other authorities for the settlement of consumer disputes and for matter connected therewith.</p> <p>Along with lectures, a quiz program was organized for the students. Students were asked questions on National Legal Service Authority, Fundamental Rights and Consumer Protection Act. Students who gave correct answers were given incentive prizes. The purpose behind organizing this quiz was to create awareness among the students about the laws and make them aware regarding the importance of following the laws. During the quiz programme Student of Maharashtra National Law University expressed their views on Legal Service Authority.
