Each Kit comprised of 9 Kg Rice, 1 Kg Edible Oil, 1 Kg Sugar, 1 Kg Pulses, 1 Kg Salt, 1 Kg Washing Powder, 2 Pieces of Bathing Soaps, 1 Detergent Bar, 1 Soap Bar for washing utensil, along with hair oil, Soya chunks, Cumin



Seeds, Red Chili Powder and Tea Powder was prepared for distribution. The House unanimously agreed to execute the same.

Agenda-4: Any other matter with the permission of the Chair.

Resolution No.4 The Principal put forth the proposal of opening Joint Account of Alumnae Association in a Nationalized Bank.
