Prof. Dr. Vijay Dighore. The Introductory Speech was delivered by the Secretary of Alumni Association Mr. Sharad Mire Report reading was carried out by Asst. Prof. Dr. Vijay Dighore. It was followed by Agenda wise discussion.

Agenda No. 1 To read and confirm the Minutes of the previous meeting.

Resolution No.1 The Minutes of the previous meeting of Alumni Association was read by the Member Secretary of the Committee Asst. Prof. Dr. Vijay Dighore and kept it before the members of the Committee for their approval. The entire Minutes were unanimously approved by the members of the Committee.

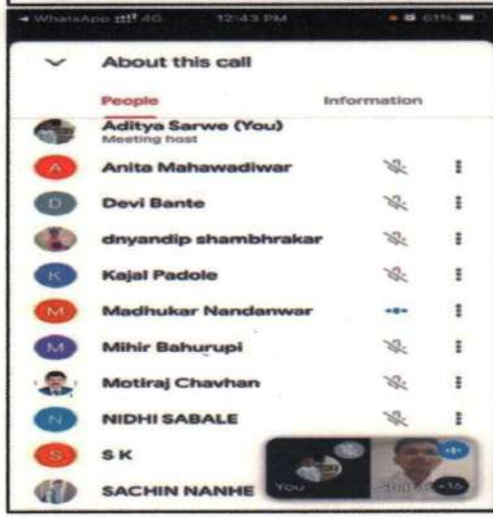


