For this, Bhiwapur Mahavidyalaya, Bhiwapur entered into an MOU with The New India Assurance Company Ltd. Nagpur, Divisional Office -2, (160200) 42, Pragati Colony, Opposite Sai Mandir, Wardha Road, Nagpur, Pin: 440015 on 09/10/2021.

As per the MOU, The New India Assurance Company Ltd. will cover all students from the College/ Institute/Department under the jurisdiction of R.T.M.Nagpur University for Personal Accident Scheme coverage including Death, Permanent Disability and Hospitalization Expenses Arising out of accident. Participation in any sports (except adventures and hazardous activities) is covered. 24 hours coverage will be within India for 1 year. Under the 'Accident Insurance Scheme', if students or parents meet with permanent disability or death, the nominee of the deceased will get Rs. 3 lakhs Assured Sum from New India Insurance Company Ltd. Nagpur. To become the Policy Holder of this Scheme, eachstudent has to pay a Premium of Rs.40 forone year.

In accordance with that Dr. Jobi George, the Principal of the College formed 'Committee for Implementing Students' Insurance Scheme in the Institution' and under his supervisionAsst. Prof. Dr. Rajesh Bahurupi, the Member Secretary of the Committee, executedall the instructions and procedures given by the Principal and the New India Assurance Company Ltd. Nagpur to implement the scheme effectively.

In the Academic Session 2021-22, the Committee succeeded to insure the lives of 342 students of Bhiwapur Mahavidyalaya. Thus, they became the Policy Holders of the Scheme by paying a Premium of Rs. 40 (Per Student) forone year. Unfortunately Mr. Devanand Narayan Giripunje, the student of B.Voc. Part-2, died in an accident at Pauni, Dist-Bhandara. A Death Claim Proposal in this regard was prepared and forwarded to the New India Assurance Company Ltd. Nagpur. The claim is still awaited.


