Administrative employees of our Institution are duty bound to complete their tasks during their office hours. While performing their duties many students and other stakeholders come in to their contacts. Though they are engaged in completing other important tasks, they have to entertain the stakeholders softly. However, mostly they couldn't deal with them in proper manner. Due to these unethical practices of the non-teaching staff, the stakeholders often get embarrassed and create problems. To avoid such unpleasant situations, the non-teaching staff should be trained to deal with the stakeholders in sophisticated manner.

- 5. Maintain the details of 'Visit Record' of stakeholders.
- 6. Try to be clam and quite in all situations.
- 7. Use appropriate words while dealing with the stakeholders.

Dr. Jobi George, the Chairperson of the Training Programme, delivered his Presidential Address. He expressed his experiences with the Administrative staff of the College that they ought to complete many assignments within the scheduled time frame. However, on many occasions, they get stressed with the worry that whether the task would be completed on time or not. This leads to improper behaviour with the stakeholders,
