## E- WASTE COLLECTION CENTRE

## **POLICY**

Bhiwapur Mahavidyalaya is committed to address the hazards posed by electronic waste (E-waste) to the environment. Recognizing the need for responsible disposal and recycling of E-waste, we have undertaken a collaborative effort with M/s. Suritex Pvt. Ltd., Nagpur, a Government-authorized E-waste recycler, to ensure the scientific and eco-friendly handling of E-waste. This initiative aligns with the safety standards established by the Maharashtra Pollution Control Board.

Our Institution has been collecting E-Waste from various Institutions, offices, and individuals and subsequently delivers it to M/s. Suritex Pvt. Ltd., Nagpur for proper recycling. We accept wide range of E-waste materials, including electrical and electronic appliances, IT hardware equipment, consumables, telecom equipment, switches, biomedical equipment, medical devices, power cords, cables, wires, chargers, paper, glass, metal scraps, or any other device powered by electricity or batteries.

Under the MOU formalized between Bhiwapur Mahavidyalaya and M/s. Suritex Pvt. Ltd., Nagpur, the latter will responsibly recycle all E-Waste collected from our College and other specified locations. Recycling will be conducted in an ecofriendly manner, adhering strictly to the norms, guidelines, and standards established by the Maharashtra Pollution Control Board. Upon completion of the recycling process, M/s. Suritex Pvt. Ltd., Nagpur will furnish a Certificate to our Institution,

certifying the total quantity of E-Waste collected and properly disposed of or recycled.

It is assured that M/s. Suritex Pvt. Ltd., Nagpur will execute the recycling process with utmost care to avoid improper disposal and any environmental hazards. Compliance with all the rules and regulations set forth by the Maharashtra Pollution Control Board and other relevant Government authorities will be maintained without any deviations.

In return for their services, M/s. Suritex Pvt. Ltd., Nagpur has agreed to compensate our College with charges amounting to Rs. 100/- per piece of monitors and CRT displays, and Rs. 15/- per kilogram for other items. GST will be applied extra as applicable.

We are committed to promote responsible E-waste management, safeguarding the environment, and contributing to a sustainable future.

- 1. The College has disbursed a sum of Rs. 15,000, exclusive of Goods and Services Tax (GST), for E-Waste Management Services.
- 2. The College has established an E-Waste Collection Centre within the Campus, operated under the auspices of Department of Physics.
- 3. Formal request letters shall be issued to various Institutions, Government Offices, and individuals soliciting the provision of E-Waste.
- 4. Periodic reminder letters will be dispatched every six months for the same purpose.
- 5. The E-Waste gathered at the centre will be dispatched for recycling every quarter during the academic session, contingent upon the accumulated quantity of E-Waste.

- 6. The College will disburse the payments of Rs. 50 per piece of monitors and CRT displays, and Rs. 10 per kilogram for other items, in consideration for the total E-Waste procured from the providers.
- 7. E-Waste providers shall furnish a formal letter to the College acknowledging the transfer of E-Waste.
- 8. If any provider wishes to donate E-Waste for a philanthropic cause, an E-Waste Donation Form will be duly furnished by the donor.
- 9. All financial transactions will be executed through Cheque or cash vouchers.
- 10. The E-Waste Collection Centre will maintain comprehensive records of all the E-Waste collected and transferred for recycling, serving the purpose of Audit compliance.
- 11. An Internal Audit of the E-Waste collected and provided will be undertaken by the local committee, presided over by the Principal of the College.
- 12. The Principal of the College reserves all rights concerning the collection of E-Waste and its subsequent provision to the recycling facility.
